RE: Electric Vehicle Charger Update

# **Recommendation:**

# Background / Analysis:

Effective January 1, 2024, a \$2.00 per hour fee was implemented for the use of public electric vehicle charges. Council requested Staff to report back on the charger usage mid-year to understand the impact of the fee.

The majority of Level 2 EV charging stations in Ontario cost between \$1.00 and \$2.00 per hour. To incentivize users, Prescott offered to charge at no cost, for an implementation period of 24 months (2022 and 2023).


# Usage Review:

Below is a graph showing the EV Charger usage for the last 2 years and 2024 year-todate (YTD). There has been a drop in usage since the implementation of the fee.



When there is no fee for use, users would possibly "top up" the battery when parked and now with a fee, this may not be as widely used or attractive.

Additional EV Charging options continue to unfold in the public and private sectors throughout Ontario such as the EV Chargers on the 401 Highway ONRoute and local fueling stations as they seek alternative power options for vehicles.



Marina chargers were off while E Dock was being replaced, for approximately 1 month.

The total number of sessions to date in 2024 is 336 and the total revenue is \$1,636.96 since the \$2.00 per hour fee implementation on January 1, 2024.

The Clock Tower parking lot continues to be the most utilized EV Chargers with 164 sessions and 455 hours and revenue of \$905.97 at the end of May 2024.

## Alternatives:

Council could decide to adjust the charging fee if they so desire.

## **Environmental Implications:**

An EV vehicle owner in Ontario can reduce their vehicle's greenhouse gas emissions by 67-95% by switching from a comparable compact, full-size or mid-size gasoline car to an electric vehicle. By choosing to drive an EV we are helping to reduce harmful air pollution from exhaust emissions.

## **Financial Implications:**

Prorating the year-to-date revenue based on 5 months, the annual revenue from the chargers will be approximately \$4,250, the electrical costs will be \$2,300, and the cellular fee of \$1,650 for all 11 chargers, making it close to net zero revenue or a small surplus.
