Re: 2024 St. Lawrence Lodge Budget

Recommendation:

That Council direct Staff to rescind the Notice of Objection to St. Lawrence Lodge for the 2024 Budget, subject to receiving the total resident days broken down by Municipal partner for the last 10 years, and

That Council direct Staff to pay the quarterly levy amount based on the revised 2024 Levy subject to receiving the total resident days broken by Municipal partner for the last 10 years, and

That Council direct Staff to put the \$102,046 difference between the original 2024 St. Lawrence Lodge Levy, and the revised 2024 St. Lawrence Lodge Levy into a reserve to help offset future increases in the St. Lawrence Lodge Levy, and

That Council ask for a formal response to the request that the St. Lawrence Lodge Board of Management undertake an Operational Review of St. Lawrence Lodge to be completed by November 30, 2024, with the intended outcome to fully analyze the organization's financial issues and produce recommendations that will stabilize and result in sustainable future municipal levy increases.

Background/Analysis:

On May 28, 2024, the St. Lawrence Lodge Board of Management approved a revised 2024 Budget which incorporates the funding details released on May 6, 2024, by the Ministry of Long-Term Care.

The provincial funding is \$1,776,604 higher than estimated in the original budget. An increase was made to the Nursing Agency expense budget from \$250,000 to \$1,325,000. The wages and benefits expenses for Nursing Direct Care were decreased by \$500,000 to reflect that contracted Nursing Agency budget increase. The use of a contracted Nursing Agency is to address unfilled vacancies. This resulted in a net increase in



expenses of \$575,000. The municipal levies were decreased by \$1,201,604 from the original 2024 Budget.

The overall 2024 municipal levy increased is 20% versus the 65% that was in the original budget. The municipal levy for the Town of Prescott is set to increase 36% due to a stated proportional increase in resident days from the Town of Prescott, however the total resident days by municipal partner have not been provided.

The Town also pays \$240,235 for long-term debt resulting from the St. Lawrence Lodge redevelopment project, with a revenue offset of approximately \$80,000 per year. A portion of the debt will be retired at the end of 2024 with the remaining amount being retired at the end of 2025.

Financial Implications:

The revised 2024 St. Lawrence Lodge Municipal Levy is \$102,046 less than the original levy. It is recommended that this amount be set aside in a reserve to help offset future increases in the St. Lawrence Lodge Levy above the rate of inflation. The Town of Prescott levy for St. Lawrence Lodge increased by 11% in 2023 and 36% in 2024. The compounding effect is an overall increase of 51% in the municipal levy paid to St. Lawrence Lodge between 2022 and 2024.
